

**CITY OF HAWAIIAN GARDENS
RESOLUTION NO. 016-2021**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HAWAIIAN GARDENS, LOS ANGELES COUNTY, CALIFORNIA, CONTINUING THE FISCAL YEAR 2020-21 BUDGET AS THE INTERIM BUDGET FOR FISCAL YEARS 2021-22 AND 2022-23 UNTIL THE ADOPTION OF THE FINAL BUDGETS FOR FISCAL YEARS 2021-22 AND 2022-23, AND AUTHORIZING EXPENDITURE OF FUNDS BY THE VARIOUS CITY DEPARTMENTS

WHEREAS, in light of the effect of COVID-19 on the City of Hawaiian Gardens' ("City") revenues, reserves, and operations, the City is still in the process of reviewing and determining anticipated revenues, expenditures, and conservation efforts for replenishing reserves for the operating budgets for Fiscal Years 2021-22 & 2022-23; and,

WHEREAS, the City Council continues to place top priority in adopting the Fiscal Years 2021-22 & 2022-23 Budgets in an expedient manner; and,

WHEREAS, it is anticipated that the final Fiscal Years 2021-22 & 2022-23 Budgets will not be completed by June 30, 2021 and instead will be presented to the City Council for adoption in July 2021; and,

WHEREAS, the City is required to make routine and monthly payments for goods, services, and miscellaneous maintenance, as necessary to continue day-to-day operations of the City, including without limitation payroll and expense disbursements, until the final budgets for Fiscal Years 2021-22 & 2022-23 are completed and adopted by the City Council.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Hawaiian Gardens as follows:

SECTION 1: The foregoing recitals are true and correct, and incorporated herein by this reference.

SECTION 2: The 2020-21 Fiscal Year Budget shall continue as the interim budget for Fiscal Years 2021-22 & 2022-23 until the Citywide Budgets are adopted by the City Council, including that the amounts set forth in the 2020-21 Fiscal Year Budget are continued, and the various City departments are authorized to spend funds, at the same level as the previous fiscal year until the Fiscal Years 2021-22 & 2022-23 Budgets are adopted.

SECTION 3: The salaries and benefits, compensation plan, and position control adopted as part of the 2020-21 Fiscal Year Budget shall remain in effect until superseded by the adoption of the Fiscal Years 2021-22 & 2022-23 Budgets.

SECTION 4: No local funds can be expended or obligated that exceed the 2020-21 Fiscal Year Budget Appropriation until a new budget is adopted. Expenditures mandated by the State or County or rules or regulations adopted by either are incorporated into this continuing budget.

SECTION 5: This resolution will become effective immediately upon adoption and will remain effective, unless repealed by the City Council, until superseded by the adoption of the Fiscal Years 2021-22 & 2022-23 Budgets.

SECTION 5: The acting City Clerk will certify to the passage and adoption of this resolution; will enter the same in the book of original Resolutions of said City; and will make a minute of the passage and adoption thereof in the record of proceedings of the City Council of the City of Hawaiian Gardens, in the minutes of the meeting at which the same is passed and adopted.
