Both Parties expect the Agreement to be executed upon within 15 business days of the Effective Date stated above. Accordingly, this Quote shall remain valid until the earlier of following: 1) the Parties execute an Agreement, or 2) 30 days from the Effective Date written above.

- Orders must be placed each Tuesday, no later than 5:00pm, for the following week of service.
- Order cancellations or modifications may be made up to three (3) business days prior to delivery. All request for modifications are subject to acceptance by Revolution Foods, depending on availability. Customer shall be required to pay full price for all



Meals ordered if not cancelled or modified at least three (3) business days prior to scheduled delivery.

- Any delivery or fulfillment errors must be reported in a detailed writing to CustomerServiceSCA@revfoods.com or [cturner@revolutionfoods.com](mailto:cturner@revolutionfoods.com) within 24 hours of delivery for adjustments or credits to Customer's invoice.

In the event there are changes to Customer's meal service needs as a result of the COVID-19 pandemic before the Agreement has been executed, Customer shall provide Revolution Foods with as much notice as is reasonably necessary, and in no event less than 3 business days, to allow the Parties to confer and agree upon substitutions or modifications to meal service. Customer acknowledges that prices may be subject to renegotiation in the event of changes to the terms stated above. In the event the Parties cannot agree on new pricing terms, Customer shall be permitted to cancel pending orders,, subject to the three (3) business day cancellation deadline stated above, cancel orders.

This Quote contains the entire agreement between the Parties and supersedes any and all prior written and/or oral agreements. This Agreement may be amended or modified only in writing signed by the Parties.
